

PRIVACY POLICY

1. General

Dupas Cosmetics respects the privacy of every individual who visits our websites. This Privacy Policy outlines the information Dupas Cosmetics will collect and how we will use that information. This Statement will also instruct you on how you can verify the accuracy of your personal information submitted to Dupas Cosmetics through this website and how you can request that we delete your personal information from our databases.

2. Personal Information

3. Use of Personal Information
